

CONTRACT

This Contract, hereinafter the **Contract**, has been made in Tallinn on _____ 201_.

AS Krediidinfo, situated at Narva mnt 5, 10117 Tallinn, company registry code 10256137, represented by the member of management board Veiko Meos, hereinafter the **Contractor** and

_____, situated at _____, company registry code _____, represented by _____ hereinafter the **Customer**, hereinafter the Party in the case of a separate indication or the Parties if jointly referred, **have agreed in the following:**

1. **Contract Object**

1.1 The object of this Contract is AS Krediidinfo Online reports, company inquires and information contained therein.

2. **Rights And Obligations Of The Contractor**

2.1 The Contractor is entitled for remuneration by the Customer for the provision of the Online services stated in 1.1 herein subject to the price list. The Contractor reserves the right to unilaterally modify the price list by giving 14 (fourteen) days' of notice thereof to the Customer.

2.2 The Contractor shall be obliged to enable an Online access to the Customer to AS Krediidinfo companies' data base on business days between 9.00 a.m. and 5.00 p.m.

2.3 The Contractor shall announce to the Customer all necessary user names and passwords in order to use the system.

3. **Rights And Obligations Of The Customer**

3.1 The Customer is entitled to have an Online access to AS Krediidinfo companies' data base with the help of the assigned user name and password, whereas the use of the service by the Customer takes place outside the Republic of Estonia.

3.2 The Customer shall be obliged to use the information from the Online data base only in its work.

3.3 The Customer shall guarantee the confidentiality of the assigned user name and password in regard of third persons.

3.4 The Customer shall be obliged to pay subject to the price list of the Contractor for the inquires sought by help of user name.

4. **Settlements**

4.1 Settlements for the works performed on the basis of this Contract shall take place once a month proceeding from the Contractor's price list and on the basis of the invoice presented by the Contractor to the Customer. The sum on the invoice shall be payable during 14 (fourteen) days to the Contractor's settlement account indicated on the invoice.

5. **Duration Of The Contract**

5.1 This Contract shall take effect from the moment of signing it by the Parties and shall remain in force for an unlimited period of time.

5.2 This Contract may be terminated upon the agreement of the Parties or on the basis of a written application by one Party. Upon unilateral termination of this Contract the Parties shall be obliged to inform the other Party in writing with at least 1 (one) day's notice.

6. **Modification Of This Contract And Settlement Of Disputes**

6.1 This Contract may be modified or improved upon the written agreement by the Parties. Modifications and improvements shall take effect from the moment of signing them by the Parties.

6.2 All disputes arising out of this Contract shall be settled by way of negotiations, unless the agreement is reached – in Harju Country Court.
